Students in grades 9-12 can have their cell phones with them during the school day. However, they should not be out during class time. High school students may use their phones between classes, during lunch, and before/after school. Technology/Chromebooks should be out as teachers decide the students should use them. If not needed during that class period, they should remain closed and under desks. Again, if students cannot follow this rule, the Chromebooks should be dropped off in a designated area before class and picked up at the end of class.
